Tai Ping is audited to ISO 14001, the international standard that specifies requirements for an effective Environmental Management System (EMS). This certification underscores Tai Ping's commitment to sustainable practices, minimizing environmental impact through responsible resource use and waste reduction, while consistently meeting rigorous environmental standards.



**Tai Ping is audited to ISO 9001,** the international standard for quality management systems based on principles such as customer focus, leadership, and continual improvement. This certification reflects Tai Ping's commitment to consistently high-quality products, reliable performance, and enhanced customer satisfaction.



**Tai Ping is audited to ISO 45001,** the standard for management systems of occupational health and safety (OH&S). The goal of ISO 45001 is the reduction of occupational injuries and diseases, including promoting and protecting physical and mental health. The standard is based on OHSAS 18001 which ISO 45001 has replaced.



Tai Ping colorants comply with the Ecological and Toxicological Association of Dyes (ETAD) recommendations on heavy metal impurities in organic dyestuffs and pigment preparations that can have an adverse impact on health and the environment.



Tai Ping is committed to full compliance with REACH (Registration, Evaluation, Authorisation, and Restriction of Chemicals), the European Union regulation focused on protecting human health and the environment from chemical risks. By ensuring that all materials meet REACH standards, Tai Ping upholds its dedication to safe, sustainable production practices and environmental responsibility.



Tai Ping's rugs and carpets are certified to ISO 16000, the European standard for testing volatile organic compounds (VOCs), ensuring they meet strict indoor air quality and safety standards. This certification underscores Tai Ping's commitment to creating products that support healthier indoor environments.



Tai Ping is certified with Green Label Plus (GLP+) certification, meeting the Carpet & Rug Institute's rigorous standards for indoor air quality (IAQ). This certification, along with independent VOC emission testing, provides evidence for LEED IEQ credits, demonstrating Tai Ping's dedication to healthier indoor environments and sustainable building practices.



Tai Ping aligns with LEED (Leadership in Energy and Environmental Design) standards, the building certification developed by the U.S. Green Building Council (USGBC). Tai Ping's rugs and carpets are designed for eligibility in the Materials & Resources (MR) and Indoor Environmental Quality (IEQ) categories, contributing up to 5 possible LEED credit points.



Tai Ping engages in the EcoVadis sustainability assessment as part of its annual CSR actions and strategy. Tai Ping achieved a Silver rating, placing it in the top 23% of assessed companies. EcoVadis evaluates companies based on environmental impact, human rights, ethics, and sustainable consumption, providing a platform for benchmarking sustainability performance and fostering transparency across supply chains.



Tai Ping rugs and carpets are certified with Health Product Declaration certificates (HPDs), providing transparency on product ingredients. HPDs meet the Health Product Declaration Open Standard, and contribute to LEED credits for sustainable building, underscoring Tai Ping's commitment to product safety and environmental responsibility.
